Eighteen holes Better-ball Stableford Competition [Maximum stroke allowance 18]:

Prizes will be presented for: Leading nett score over 18 holes 1st - 2nd - 3rd - 4th - 5th

- The competition is open to pairs of players of amateur status as defined by the Royal and Ancient Golf Club of St. Andrews and who are members golf clubs affiliated to the Nottinghamshire Union of Golf Clubs and who are members of the Nottinghamshire Union of Golf Clubs County Membership Scheme and / or the Nottinghamshire Union of Golf Clubs County Membership Card Scheme, handicap limit of 18 or under per player.
- Should it become necessary to restrict the number of competitors, entrants will be balloted strictly in accordance with their date of entry.
- Competitors are only allowed to take one prize.
- Ties in the 18 hole events will be decided over the last 9 - 6 - 3 - 2 - 1 - 15 or 12 holes in that order.
- The entrance fee of **£ 20.00** must be received, at the following address, by not later than 12.00 noon on Monday, the 19th July, 2010, on the specified form attached below:

- No entries will be accepted by telephone or after the closing date for entries.
 - No refunds will be allowed after the closing date for entries.
 - The draw and starting times will be communicated to each Golf Club prior to the competition. If a player requires an individual copy of the draw, a stamped, self-addressed envelope must be enclosed with the entry fee and application form.
 - The Committee of the Union reserve the right to refuse an entry of any of the intending competitors.
 - Competitors may use motorised golf carts on medical grounds only, and only when the golf club allows their use.
 - If a player suffers from a condition which may require urgent medical attention [e.g. asthma, diabetes, epilepsy, etc.] it is important the player notify a member of the Committee and direct the Nottinghamshire Union of Golf Clubs accordingly in the event of an attack.
 - Conforming golf balls: The ball the player plays must be named on the current List of Conforming Golf Balls issued by the R & A Rules Limited. Penalty for breach of the condition: Disqualification.
 - Conforming golf clubs: Driving clubs must not have a characteristic time greater than 257 microseconds when measured on pendulum testing apparatus approved by the R & A Rules Limited. See Appendix II, 5a of the Rules of Golf. Penalty for breach of the condition: Disqualification.
 - Distance Measuring Devices: Players are permitted the use of a distance measuring device for the purpose of measuring distance only. Artificial devices or unusual equipment designed to gauge or measure other conditions that might affect the play of a competitor [e.g. gradient, windspeed, temperature, etc.] is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional function is actually used
 - Neither the Trent Lock Golf Club or the Nottinghamshire Union of Golf Clubs accept any responsibility for the loss or theft of a player's golf equipment or personal effects and player's are advised to carry adequate insurance cover.
 - Any points arising in connection with the play will be settled by the Committee appointed for the purpose of this competition whose decision shall be final.
